# Citizens' Bond Oversight Committee 2021-2022 Annual Report

### Compton Community College District Citizens' Bond Oversight Committee Annual Report – Introduction

As outlined in Education Code Section 15278, the role of the Compton Community College District (CCCD) Citizens' Bond Oversight Committee is to "inform the public concerning the District's expenditure of revenues received from the sale of bonds authorized by the voters." Members are appointed for two years, with a three-term maximum. Members do not receive any compensation or benefits for their service. The committee meets a minimum of four times per year.

As mandated by Proposition 39, the CCCD Board of Trustees is required to appoint an independent citizens' oversight committee of at least seven individuals. Each member must represent one of the following constituencies: a local business, a senior citizen organization, a bona fide taxpayer's association, an enrolled student active in a student group, and an active member of a college supporting organization, such as the foundation or a community advisory group. No District employee or official, vendor, contractor, or consultant may serve on the committee.

During the 2021-22 fiscal year, the Citizens' Bond Oversight Committee met a total of four times.

# **Executive Summary**

The charter of the Compton Community College District Citizens' Bond Oversight Committee is to inform the public concerning bond revenue expenditures and to actively "review and report" on the expenditure of these funds. Our committee comprises a cross section of the citizenry who have volunteered their time to represent various constituencies, and fulfill the responsibilities listed above.

During this year of existence, the committee has met on a regular basis to assess the progress of various facilities projects. This Annual Report of the Compton Community College District Citizens' Bond Oversight Committee documents the results of these activities and serves to fulfill the basic tenets of the charter.

#### **Elizabeth Atkinson**

Atkinson is a social worker for in-home supportive services at the Los Angeles County Department of Public Social Services, where she has worked since 1989. - VIII. Discussion Items
  - a. Proposition 39-General Obligation Bonds Dr. Abdul Nasser gave a presentation that included:
    - i. Overview of Prop 39
    - ii. Performance Audit Objectives

The committee members were provided with a handout. Rodney Lister asked for the aging of the bonds. Dr. Nasser will look into it and follow up with the committee at a later date.

Crystal Moore asked what projects are being planned and Linda Owens will provide that information in the upcoming item.

- b. Facilities Update Linda Owens-Jackson, Chief Facilities Officer
  - i. Linda Owens-Jackson provided a handout to the committee and reviewed the current and upcoming facilities projects.

Rodney Lister asked if a pool is included in the PE Complex because it is vital to his history and the community. Linda Owens-Jackson answered yes. Rodney Lister would like to know if the pool will be open to the community. Linda Owens-Jackson will find out and bring that back to the committee.

Crystal Moore said the updating of the buildings make the campus feel more collegiate.

Elizabeth Atkinson asked about the purpose of the large holes that need to be dug and Linda Owens-Jackson said there are liquefaction and soil issues.

Rodney Lister asked if locker rooms will be in the gym and Linda Owens-Jackson said yes. Rodney Lister also asked what building codes we follow and Linda Owens-Jackson replied state codes.

Adele Johnson asked the number of seats in the Little Theater and Linda Owens-Jackson said about 200 and that will stay, but it is being renovated.

Elizabeth Atkinson asked if there will be student housing on campus and Linda Owens-Jackson replied yes, but it is not bond related so it is not included on this list.

Crystal Moore is concerned about the new student lounge area because it is dusty and Linda Owens-Jackson replied that is due to the construction site of Instructional Building #2 right behind it and that there are student spaces in the vocational technology building, the student success center, and math science building with new furniture.

# Overview – Prop 39 Bond

# <u>General</u>

- Approved by voters on November 7, 2000
- Allows school and community college districts to pass a local general obligation bond with a vote of 55% (traditional bond: two-thirds of vote)
- Districts elect whether to issue a "Prop 39 bond" or a "traditional bond"
- Districts must provide voters with a list of specific projects to be funded by the bond (*Article XIIIA, sec. 1(b)(3)*)
  - Voter ballot vs. facility master plan
- Prop 39 bonds come with additional restrictions and oversight requirements

# Proceeds of Prop 39 Bond

- Limited to the following uses (*Article XVI, Sec. 18(b)*):
  - Construction
  - Reconstruction
  - Rehabilitation
  - Replacement of school facilities
  - Furnishings and equipment
  - Acquisition or lease of real property
- Cannot be used for administrative or operating costs
- Cannot be used for general maintenance
- Must be spent on voter approved projects





# Performance & Financial Audit

- Districts must conduct annual, independent performance and financial audits until all of the proceeds of the bond are exhausted (*Article XIIIA*, *Sec. 1(b)(3)(C)*).
- Performance audit ensure that the bond proceeds were expended only on the specific projects (voter ballot or facilities master plan).
- Financial audit similar to a regular financial statement audit, but for the bond fund only.





# Citizens' Oversight Committee (Ed. Code Sec. 15278)

- Governing board of the district must appoint a 7-member Citizen's Oversight Committee (COC) within 60 days of the passing of the Prop 39 bond.
- COC shall review and actively report on the proper expenditure of taxpayers' money for school construction.
  - Bond revenues are expended only for the allowed purposes.
  - No funds are used for any teacher or administrative salaries or other school operating expenses.





# Citizens' Oversight Committee (Ed. Code Sec. 15280)

- Without expending bond funds, the governing board of the district shall provide the COC with (1) any necessary technical and administrative assistance in furtherance of its purpose and (2) sufficient resources to publicize the COC's conclusions.
- Committee proceedings shall be open to the public.
- COC shall issue regular reports on the results of its activities (at least once per year).
- Minutes of meetings and copies of all documents shared with COC shall be made available to the public via the district website.







# Citizens' Oversight Committee (Ed. Code Sec. 15282)

- Minimum of 7 members and consist of the following:
  - Active member of a business organization
  - Active member of a senior citizens' organization
  - Active member of a bona fide taxpayers' organization
  - School district:
    - Parent or guardian of enrolled child
    - Parent or guardian of enrolled child <u>AND</u> active in a parent-teacher organization
  - Community College District:
    - ◊ Student currently enrolled and active in a college group
    - Active in the support and organization of a community college (such as, a member of an advisory council or foundation)





# Citizens' Oversight Committee (Ed. Code Sec. 15282)

- COC members may <u>not</u> include:
  - District employee or official
  - Vendor, contractor, or consultant of the district
- Minimum term of 2 years
- No more than 3 consecutive terms

# **Compliance requirements**

- Select a representative sample of expenditures charged to the facilities project(s) and review supporting documentation to ensure that such funds were properly expended on specific projects listed in the text of the applicable ballot measure.
- Verify that the funds were generally expended for the construction, renovation, furnishing and equipping of school facilities constituting authorized bond projects.
- Verify that the funds used to pay the salaries of district employees were allowable per Opinion 04-110 issued on November 9, 2004 by the State of California Attorney General.
- If the school district did not properly account for the expenditures, if such expenditures were made for unauthorized bond projects, or if salary transactions were used for general administration or operations, include a finding in the audit report.
